New to Camp Dog Works? We ask that you visit the kennel with your pet before we accept any reservations. Please email dogworks@bellsouth.net or call 828 697-2604 to set up an appointment. To Reserve your first dates, this form is to be brought to the kennel when you visit us for the first time. Include a copy of your shot record. New clients are required to pay 50% of board bill at beginning of first visit. Returning clients need to fill out and bring this form with you the first time you board in a calendar year. Returning clients with up-to-date forms on file may email dogworks@bellsouth.net to reserve dates. Please put Kennel Reservation in subject line and always include drop off and pick up times as well as reservation dates and your daytime phone number.

Check in and out times: Limited to the time between 9:30 and 10 AM or 5:30 and 6 PM. Other times can be arranged for a \$15 added fee. You will be billed for the whole day anytime your pet is in the kennel after 10 am. If you check in a 6 PM and out at 9:30 AM the next day, you owe for one day. If you check in at 6 PM and out at 6 PM the next day, you owe for two kennel days.

Fees: \$20 per day for the first five days. Daily fees drop to \$15 on day 4 through day 20. After day 20, fees drop to \$10. **HOLIDAY RATES** are \$25 per day the day before, day of, and day after a major holiday which include July 4, Memorial Day, and Labor Day To reserve a holiday date, all clients must send a non-refundable 20% deposit before we reserve your dates. Ask about our second dog discount and our 5th stay 20% discount. **Print Clearly**

This is a contract between Camp Dog Works and _____

Owner agrees to pay the daily rate of \$20 per day, first 5 days, \$15 for 6 - 20 days, \$12 for 21 or more days for regular boarding. Holiday board is \$25 per day for the day before, day of, or day after any major holiday. First time boarders are required to pay 50% of board bill upon drop off. To reserve a holiday date, a 20% non refundable deposit must be received before space is reserved. Owner understands the added fee of \$15 for any and all pickups or drop offs falling outside the normal time windows of 9:30 to 10 AM or 5:30 to 6 PM. Any dog left in the kennel after 10 AM will be billed for the entire day. Owner further agrees to pay all costs and charges for special services requested and all veterinary costs for the dog during the time said dog is in the care of Dog Works. Owner further agrees that the pet shall not leave Dog Works until all charges are paid to Dog Works by Owner. By signing this Contract, Owner certifies the accuracy of all information given about said pet.

Owner has viewed the kennel conditions and has accepted said conditions. Owner understands that dogs, even when kept with the greatest of care, may have accidents such as, but not limited to, sprains, chokes, bloat, etc. Dog Works shall exercise reasonable care for the dog delivered by the Owner to Dog Works. It is expressly agreed by Owner and Dog Works that Dog Works' liability shall in no event exceed the lesser of the current chattel value of a dog of the same species or the sum of \$200.00 for each animal boarded. The Owner further agrees to be solely responsible for any and all acts of behavior of said pet while it is in the care of Dog Works.

Owner specifically represents that he or she is the sole owner of the dog, free and clear of all liens and encumbrances and that the dog has not been exposed to Rabies, Distemper, or Parvo within a thirty day period prior to boarding. Owner will provide proof of current vaccinations, including Kennel Cough.

All charges incurred by Owner shall be payable upon pick-up of dog; or when billed by Dog Works. Dog Works shall have, and is hereby granted a lien on the pet of any and all unpaid charges resulting from boarding dog at Dog Works. The Owner hereby agrees that in the event the boarding charges are not paid when due in accordance with this contract, Dog Works may exercise its lien rights upon ten days written notice given by Dog Works to Owner by certified mail. Dog Works may dispose of the dog for any and all unpaid charges, at private or public sale, in the sole discretion of Dog Works, and Owner specifically waives all statutory or legal rights to the contrary. If such sale shall not secure a price adequate to pay such costs of board or other charges delinquent, plus costs of sale, the Owner shall be liable to Dog Works for the difference. All monies realized by dog Works at such sale, over and above the charges due and costs of sale, shall be paid by Dog Works to Owner.

If dog becomes ill or if the state of the animal's health otherwise requires professional attention, Dog Works, at its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the dog and the expenses thereof shall be paid by Owner.

This Contract contains the entire agreement between the parties. All terms and conditions of the Contract shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and Dog Works. In any litigation arising out of or relating to this contract or the breach thereof, the prevailing party shall be entitled to recover reasonable attorney fees and costs.

1. ***Email usually works best.*** dogworks@bellsouth.net Use email to reserve dates. When making email reservations use ***“boarding reservation request”*** as the **subject line** of your email. Email reservations must **include your full name, dogs name, daytime & cell phone numbers, dates and TIMES of your drop offs and pick ups.**
2. We will respond within 36 hours after receiving your email request. If you do not hear from us within 36 hours, assume that we did not get your email.
3. ***Phone number: 828 697-2604.*** There is no recording answering machine on this line. We answer the phone when we hear it ring. Since we operate a working farm, we are away from the phone much of the day. A good time to reach us is right after dark, but no calls after 9 PM please.
4. ***Maureen’s*** cell phone is 329 6084, Lee’s is 329 6086. Do not use these numbers unless it is critical to reach us as in an emergency situation. (Unexpected family death and you must drop off a dog in the next hour). Absolutely do not use our cell numbers to check on the well being of your pet or to make a normal reservation. Trust us to call your cell number at the first sign of any trouble with your pet.
5. ***No News Is Good News!*** Let me know if you will be checking your email while away from your pet. Sometimes I have my camera with me and will be happy to send a quick pic of your pet. If you email me while you are gone, use “Checking on Fido” as the subject line.
6. ***Food:*** unless your pet is staying longer than 10 days, we want you to measure out the portions of kibble, bag it and label the bag with your pet’s name. If your pet eats the same amount for AM and PM feedings, you may use one bag per day marked as such. Make sure we write “half per meal” on the food storage box as well as each bag. Do not bring us a full 50 lb bag of kibble if your pet is staying 2 weeks and will eat 20 pounds of food. Our kennel is small. For long visits, if you have a container, great! If not, we have some that will hold 30 pounds. Always check your stall sheet to make sure our information is correct. Often owners change brands of food and we will need to know this.
7. ***Do not bring*** food bowls, rawhide chews, tennis balls, latex toys, stuffed toys with squeakers, rope tugs, or valuable bedding. Acceptable toys are made of hard rubber and will have pet’s name on it. Leash your pet before getting it out of car or dog run. Remember to take leash home after drop off. Any items left will be tossed 3 days after check out.
8. ***You will be charged the added \$15 fee if your pick up or drop off does not fall within 9:30 and 10 AM or 5:30 and 6 pm. We must be informed prior to any special drop off or pick up times.***
9. ***Please understand billing:*** If you check in at 6 PM and out at 9:30 AM the next day, you owe for one day. If you check in at 6 PM and out at 6 PM the next day, you owe for two kennel days. **Check out is 10 AM!**

Please inform us of any special request and concerns you may have. It is your responsibility to check information we put on your pet’s stall during check in each time you board with us.

Directions to the Kennel are not the same as the training building!

From Greenville, SC: travel North on HWY 25 to exit 5, Carl Sandburg, Flat Rock Exit. Turn left onto 255N. Take the first road to the Right, Zirconia Road. Immediately cross RR tracks, putting you on Old Zirconia Road. Continue down Old Zirconia Road until it becomes gravel. After crossing the third RR track, turn carefully onto the gravel road and go 200 ft., take the sharp turn back to the left.(Smyre Road) Turn right on first drive, (Smyre Place Lane). Look for a pineapple on this looped drive. Do not go up the drive with the pineapple, take the drive near the mail boxes. Go 150 feet, Turn right onto Summit Farm Lane. Turn right again to go down to barn. Drive straight past barn and you will be at the kennel. Park parallel to the chain link fence.

From Spartanburg, SC: Take the Saluda Exit 59, then turn left , continue to HWY 176 and turn right onto Hwy 176. Go through Saluda and continue on Hwy 176 approximately 4.5 miles. Cross large Green River Bridge and turn left .4 miles from this bridge onto North Lake Summit Road. (first left after bridge) Bear right on Smyre Road,don't go down to lake. Turn left onto Smyre Place Lane (Large Pineapple), but go up the easy side, closest to mailboxes. Go 150 feet, Turn right onto Summit Farm Lane. Turn right again to go down to barn. Drive straight past barn and you will be at the kennel. Park parallel to the chain link fence.

From Asheville, NC: I 26 to exit 54, HWY 25. Cross over HWY 176. Continue until you get to the exit 5, Flat Rock/Carl Sandberg Exit (which is in a somewhat hidden curve). Turn Right onto 225N going uphill. Go about 1/4 mile to the Zirconia Road/Old Zirconia Road junction on the Right. Turn Right and cross the Railroad track immediately onto Old Zirconia Road. Dog Works is about 1 mile down Old Zirconia Road (which transitions into Smyre Road shortly after the third Railroad crossing). Dog Works is on the Left about 200 yards past the crossing.The kennel is located in our home, not the Dog Works training building. After crossing the third RR track, turn carefully onto the gravel road and go 200 ft., take the sharp turn back to the left. (Smyre Road) Turn right on first drive, (Smyre Place Lane). Look for a pineapple on this looped drive. Do not go up the drive with the pineapple, take the drive near the mail boxes. Go 150 feet, Turn right onto Summit Farm Lane. Turn right again to go down to barn. Drive straight past barn and you will be at the kennel. Park between the house and the chain link fence.

From Hendersonville: You may take 225 South from Fresh Market, past Flat Rock Play House and Kenmure. Turn left onto Old Zirconia Road, just past the Zirconia Post Office on the right. If 225 becomes a 4 lane, you missed Old Zirconia Road!Go 1 mile and three RR crossings. After crossing the third RR track, turn carefully onto the gravel road and go 200 ft., take the sharp turn back to the left.(Smyre Road) Turn right on first drive, (Smyre Place Lane). Look for a pineapple on this looped drive. Do not go up the drive with the pineapple, take the drive near the mail boxes. Go 150 feet, Turn right onto Summit Farm Lane. Turn right again to go down to barn. Drive straight past barn and you will be at the kennel. Park between the house and chain link fence. ***Or you may use Asheville Interstate 26 Directions.***

From Brevard: Come to Flat Rock Play House, (there is a back way if you know it) located on Hwy 255 South and follow the first Hendersonville directions.
